California Proposition 65 • American Acoustical Products

The California Safe Drinking Water and Toxic Enforcement Act of 1986, better known as Proposition 65 or "Prop 65", requires businesses to give a "clear and reasonable warning" to individuals in California before knowingly and intentionally exposing those individuals to significant levels of a chemical on the state's list of known carcinogens and reproductive toxins. The Office of Environmental Health Hazard Assessment (OEHHA) administers Proposition 65, including maintaining the state's list of known carcinogens and reproductive toxins. The list is available at https://oehha.ca.gov/proposition-65/proposition-65-list.

Because Proposition 65 is a "right to know" law, products exposing individuals to listed chemicals above certain levels must include "clear and reasonable" warnings, but this does not mean the products are unsafe. As OEHHA has explained: "A Proposition 65 warning does not necessarily mean a product is in violation of any product-safety standards or requirements."

A number of American Acoustical products necessarily contain chemicals on the Proposition 65 list to support the products' function. American Acoustical Products includes information on Proposition 65 chemicals in our product specific SDS's, in our Product Data Sheets, and if applicable on our quote responses to RFQ's.

American Acoustical Products does not sell products directly to California Consumers, nor does American Acoustical Products offer products for sale online. Manufacturers can comply with Proposition 65 by providing downstream customers with warnings for the products they supply, and directing downstream customers to provide those warnings to consumers. For products sold online, warnings are to be provided on the product display page (or otherwise in association with the product prior to checkout). For catalogs, warnings are to be provided in a manner that clearly associates it with the item being purchased. For direct sales to California consumers, package labeling may be required. An example of the format of a Prop 65 consumer warning is:

WARNING This product can expose you to chemicals including [insert chemical name], which are known to the State of California to cause [insert risk category(s)]. For more information go to www.P65Warnings.ca.gov.
